I am writing in response to your inquiry concerning the sale and rental of pumping equipment to a contractor involved in the construction and maintenance of sewerage pump stations for municipal, industrial and commercial applications.

The Sales and Use Tax Act provides an exemption for machinery, apparatus, and equipment for use in the operation of a sewerage system. N.J.S.A. 54:32B-8.13(b). Pump station components for sanitary sewer system access are entitled to exemption when purchased by a contractor for installation as a component of the real property. For purposes of the exemption, it doesn't matter whether the sewerage flows into the municipal sewerage system or is treated "in house." As long as you are selling qualified equipment as opposed to providing pumping services to contractors, you may accept an Exempt Use Certificate (ST-4) from your customers. This is not clear from your letter, since you mention supplying "rental" equipment which seems to negate the intent of the exemption.
